

2009 FISA Australian Classification Workshop AIS, Canberra ~ 13-15 November

Rowing Australia will be conducting a National Adaptive Rowing Classification Workshop in Canberra between Friday 13th November and Sunday 15th November 2009. This workshop will be presented by Judy Morrison, FISA Head of Classification and member of the FISA Adaptive Rowing Commission and Shirley Stokes, FISA International Technical Classifier and member of the FISA Adaptive Commission. Also in attendance will be Rebecca Orr, FISA International classifier from Toronto Canada. An Athlete Classification Session will be conducted as part of the workshop, during which athletes will have the opportunity to gain a Confirmed International Classification for all International Competition, including the 2012 London Paralympic Games.

A Bulletin with further details of this workshop and classification session is provided attached. Rowing Australia is seeking applications from those current National Classifiers and those looking to become National Classifiers as well as the athletes wishing to be involved in the athlete classification session.

The workshop will be held to coincide with a Paralympic Preparation Program (PPP) Camp. Athletes and coaches that are invited to this camp will be fully funded to attend, and the camps structure will be shaped around the classification workshop to include on water training and an opportunity to be classified, and to assist with classifier training.

The workshop and classification sessions will be free of charge, however costs may be incurred for some participants who are not attending the PPP camp who will be required to arrange their own accommodation and travel.
